Assignment

You have 90 minutes to write a 250-word story previewing an event that will take place at your school on Monday, Feb. 25.

Background

The National Federation of State High School Associations (NFHS) recently approved new rules for the 2013 football season. The NFHS wants to minimize player injuries related to helmets coming off during the game.

Last year, the NFHS changed a substitution rule. Players now must sit out one play if their helmet comes off while the ball is live. This year, the NFHS Football Rules Committee approved three additional rules that are extensions of that change.

- An illegal personal contact foul was added to Rule 9-4-3: "No player or nonplayer shall initiate contact with an opposing player whose helmet has come completely off."
- A new listing in Rule 9-6-4 will state that it is illegal participation
 "for a player whose helmet comes completely off during a
 down to continue to participate beyond the immediate action
 in which the player is engaged."
- In Rule 3-5-10, if the helmet comes completely off during the down (which is what the rule was changed to in 2012) or subsequent dead-ball action related to the down (this is the new part) – and is not directly attributable to a foul by the opponent – the player must leave the game for at least one down, with the exception of halftime or overtime intermission. When this occurs, an official's time-out shall be called.

diagnosed with chronic traumatic encephalopathy (CTE). Last month, Seau's family filed a wrongful death lawsuit against the NFL.

In response to increasing awareness of the dangers of concussions and brain injuries triggered by school sports, State Rep. Carol King (D-Aspera), will host a forum on preventing football head injuries from 7 p.m. to 9 p.m. Monday, Feb. 25 at Ad Astra High School.

Ad Astra Principal Emmylou Harris and the school's football trainer did an informal study

of the Box Turtles' varsity football practices and games the last three years. Harris and trainer Jacques Strappe estimate that 20 different AAHS players have sustained a total of 32 concussions in that time, or about 1.6 concussions per affected player. Divided by three years, that about seven players and 11 concussions per year.

"Player safety has been and will continue to be the top priority for members of the NFHS Football Rules Committee. These rules changes regarding helmet-less players are more examples of the group's commitment to minimize risk within the game."
